Privacy Policy mobile pay

micropayment GmbH, Scharnweberstrasse 69, 12587 Berlin (Germany)

The protection of your personal data is taken very seriously by us. We treat your personal data confidentially and in accordance with the statutory data protection regulations and this privacy policy.

This privacy policy informs you about the handling of your data when you pay with mobile pay.

How mobile pay works:

mobile pay is a telephone-based method of payment and can be done via PIN/TAN by the landline telephone or via SMS by your mobile phone.

Payment by PIN/TAN

You will be asked to enter your mobile number. Subsequently, the associated telephone provider is determined. Within the next few seconds, we will send a unique and non-manipulable payment code via SMS to your mobile phone. This process is free of additional costs for you. Depending on your telephone service provider, additional steps may be required. By entering the received payment code afterwards, the payment processed is finished. The billable amount will be debited by your mobile service provider with your next bill.

Payment by SMS

When paying by SMS, you will receive a personal code and a phone number. Please send the code to the displayed number with your mobile phone. Depending on your telephone service provider, additional steps may be required. The billable amount will be debited by your telephone operator with your next bill.

An overview of the transactions made with your telephone number or the possibility to cancel current subscriptions can be found at <https://customercenter.micropayment.de>. After logging in with your mobile number, you will be able to view payments made and manage an existing subscription.

What data is saved when using mobile pay?

As part of the payment process via mobile pay, the following data will be processed by us:

- your phone number,
- your ip-address,
- the website you visited and
- transaction details (date, time, amount etc.).

Transfer of your data for the purpose of accounting

For accounting purposes, we pass your data to the billing operator *DIMOCO Europe GmbH, Campus 21, Europaring F15/302, 2345 Brunn am Gebirge/Vienna (Austria)*. This ensures that your transaction data is billed by your telephone company on your phone bill.

Legal basis of data processing

The collection, storage, transfer and processing of your data is based on Art. 6 section 1 letter a GDPR (consent) and Art. 6 section 1 letter b GDPR (processing to fulfill a contract).

How long is the data stored?

We store your data for the duration of the respective processing purposes (eg contract execution) and as long as the storage of your data is necessary for the fulfillment of commercial and fiscal storage regulations (Art. 6 section 1 letter c GDPR).

Data security

We protect your privacy through technical and organizational measures. To ensure a secure transmission of personal information, we use the SSL 3.0 encryption protocol. This method is used successfully throughout the World Wide Web. All personal data (name, address, payment details, etc.) are encrypted and thus securely transmitted on the Internet. You can tell by an icon (closed padlock) in the lower window bar of your browser that you are moving in a secure area.

Location of data processing

The processing of your data by our company generally takes place in Germany. Personal data are not transmitted in any form to third countries outside the EU.

Cookies

Our payment windows use partially so-called cookies. Cookies do not harm your computer and do not contain viruses. They serve to make our offer more user-friendly, effective and secure. Cookies are small text files that are stored on your computer and saved by your browser.

Most of the cookies we use are so-called "session cookies". They are automatically deleted after your visit. Other cookies remain stored on your device until you delete them. You can set your browser so that you are informed about the setting of cookies and allow cookies only in individual cases, the acceptance of cookies for certain cases or generally exclude and activate the automatic deletion of cookies when closing the browser. When deactivating cookies, the functionality of our payment windows may be limited.

The use of cookies is based on Art. 6 section 1 letter f GDPR (processing is necessary to ensure the legitimate interests of the controller or a third party).

Analysis software Matomo

Our payment windows use the open source web analytics service Matomo. Matomo also uses "cookies", which are text files stored on your computer that allow us to analyze the use of our payment windows. For this purpose, the information generated by the cookie about the use of this website is stored on our server. Your IP address will be anonymized before being stored in the cookie.

The information generated by the cookie about the use of this website will not be disclosed to third parties. You can prevent the storage of cookies by a corresponding setting of your browser software; however, we point out that in this case you may not be able to use all the features of our offer in full.

If you do not agree with the storage and use of your data, you can disable the storage and use of the link below. In this case, an opt-out cookie is deposited in your browser which

prevents Matomo from saving usage data. Deleting your cookies will result in deletion of the Matomo opt-out cookie as well. The opt-out must be reactivated when visiting our site again.

Right of information, cancellation, blocking and revoking

At any time you have the right to free information about your personal data saved by us, their origin and recipient and the purpose of the data processing and a right to correct, block or delete this data.

Furthermore, you have the option to **revoke** your consent to the data processing at any time. Revocation does not affect the effectiveness of historical data processing operations.
